Secured summary judgment in favor of owner of large building complex avoiding low income housing obligations under the Federal Low Income Housing Tax Credit Program.

Represented homeowner's association (121 units) in construction defect case against developer, contractor and window manufacturer resulting in an agreement to perform a complete repair at no cost to the HOA, plus a cash settlement.

Prevailed in contribution/indemnity claim against general contractor arising out of a C-1 quadriplegic injury.

Obtained multiple six figure judgments in favor of contractors performing commercial work including soil, foundations, parking lots, framing, siding and roofing.

Successfully defeated \$1 million punitive damage claim and limited wrongful death damages to below \$10,000 in defense of residential care facility.

Obtained more than ten defense verdicts from juries in actions where negligence was admitted.
