## **Thomas W. Brown**

Thom Brown is a 1980 graduate of the night school program at Northwestern School of Law, Lewis & Clark College. He is admitted to practice before all federal and state courts in Oregon, the United States Court of Appeals for the Ninth Circuit, and the Supreme Court of the United States.

During law school, Thom served as a clerk to Judge Irving M. Steinbock of the Multnomah County Circuit Court (1978-80). Following law school, Thom served as a clerk to Judge William L. Richardson of the Oregon Court of Appeals (1980-81). He then joined Cosgrave Vergeer Kester in 1981. From 1994-2010, Thom was the firm's managing partner and, since 2014, has been special counsel to the firm.

Thom's been "AV Preeminent" rated by Martindale Hubbell since 1985. In 2000, Thom was selected as fellow in the American Academy of Appellate Lawyers. In 2008, Thom was selected as a fellow in the Honorary Trial Society of Litigation Counsel of America, and he has also been selected for The Best Lawyers in America (Appellate Practice (2006-21) and Insurance Law (2010-21), Benchmark: Appellate (Ninth Circuit 2012-13), and as an Oregon Super Lawyer (Appellate Practice 2006-17; Alternative Dispute Resolution 2018-2020). Thom has facilitated approximately 60 mediations for the Oregon Court of Appeals appellate settlement program covering a wide range of legal disputes. He has also served as a mediator in approximately 55 cases through private retention, and is an approved mediator for the United States District Court for the District of Oregon, The State of Oregon Environmental Claims Mediation Program, the Oregon State Bar Fee Dispute Resolution Program, and the American Health Law Association (AHLA) Dispute Resolution Service.

Thom has handled approximately 75 arbitrations through the American Arbitration Association (AAA), the Arbitration Service of Portland (ASP), AHLA, and metropolitan area circuit courts. He is an approved arbitrator for commercial cases and appeals nationwide administered through AAA, and an approved arbitrator and hearings officer for health care cases nationwide administered through the AHLA.

On appointment by the Oregon Supreme Court, Thom serves as circuit court judge pro tempore. He has heard and resolved over 185 motions for summary judgment in his 11 years as a pro tem covering a very wide range of civil disputes and issues.

Through wide-ranging and long practice experience, long time involvement in firm management, frequent leadership of professional organizations, and significant work as a neutral and pro tem judge, Thom has the skill, background, experience, and temperament to both fairly and efficiently resolve all kinds of civil legal disputes as an arbitrator or hearings officer and facilitate the resolution of all kinds of civil legal disputes as a mediator.
